ORANGE COUNTY BROADBAND AUTHORITY MINUTES

At the Organizational Meeting of the Orange County Broadband Authority held on Tuesday, March 28, 2017, beginning at 4:00 p.m., in the Meeting Room of the Gordon Building, 112 West Main Street, Orange, Virginia. Present: James K. White, Chair; R. Mark Johnson, Vice Chair; S. Teel Goodwin; James P. Crozier, and Lee H. Frame. Also present: R. Bryan David, County Administrator; Thomas E. Lacheney, County Attorney; and Alyson A. Simpson, Chief Deputy Clerk.

RE: ORGANIZATIONAL MEETING

RE: APPOINTMENT OF OFFICERS

The floor was opened for nominations for Chair. Mr. Johnson nominated Mr. White to serve as Chair. There being no further nominations, the floor was closed.

On the motion of Mr. Johnson, seconded by Mr. Goodwin, which carried by a vote of 5-0, the Authority appointed Mr. White to serve as Chair for the remainder of the term as established in the Bylaws, through such time the Organizational Meeting was conducted in 2018.

The floor was opened for nominations for Vice Chair. Mr. Frame nominated Mr. Johnson to serve as Vice Chair. There being no further nominations, the floor was closed.

On the motion of Mr. Frame, seconded by Mr. Goodwin, which carried by a vote of 5-0, the Authority appointed Mr. Johnson to serve as Vice Chair for the remainder of the term as established in the Bylaws, through such time the Organizational Meeting was conducted in 2018.

The floor was opened for nominations for Secretary and Treasurer. Mr. Frame nominated R. Bryan David, County Administrator, to serve as Secretary and Treasurer. There being no further nominations, the floor was closed.

On the motion of Mr. Frame, seconded by Mr. Johnson, which carried by a vote of 5-0, the Authority appointed R. Bryan David to serve as Secretary and Treasurer for the remainder of the term as established in the Bylaws, through such time the Organizational Meeting was conducted in 2018.

RE: FY2016 - 2017 OPERATING BUDGET UPDATE

R. Bryan David, County Administrator, provided an update to the Authority on its Fiscal Year 2017 Operating Budget, which had been adopted on July 26, 2016. He explained that the Budget was currently supported by the General Fund, and the appropriations were intended to cover expenses related to work performed by Blue Ridge Advisory Group and Federal Engineering.

The Authority took the information regarding the Fiscal Year 2017 Budget under advisement, and there was no action taken at this time.

RE: <u>PUBLIC SAFETY TELECOMMUNICATIONS PROJECT AND RURAL BROADBAND</u> INITIATIVE UPDATE

R. Bryan David, County Administrator, provided an update on the Public Safety Telecommunications Project and Rural Broadband Initiative, noting the work being completed by both the Blue Ridge Advisory Group and Federal Engineering. He explained that technical specifications were being finalized for release of an RFP and that interviews were being conducted by Blue Ridge Advisory Group for completion of an Assessment.

Discussion ensued regarding: the number of towers and design for the projects; community needs; bandwidth and speeds for potential broadband service; fiber lines; and taking a phased approach.

The Authority took the information regarding the Public Safety Telecommunications Project and Rural Broadband Initiative under advisement, and there was no action taken at this time.
